

# TRPC NEW MEMBERSHIP APPLICATION PROCEEDURE

Contact TRPC and request a NEW MEMBERSHIP APPLICATION PACKET by submitting a **nonrefundable** fee of **\$53.75** (\$50.00 + \$3.75 FL Sales Tax) which will be applied to the \$250.00 initiation fee plus the \$100.00 first year's dues when the applicant has been accepted for regular membership. **(Please note: all fees are + FL Sales Tax)**

THE PROCESS CAN BE INITIATED IN ANY OF THE FOLLOWING WAYS.

1. Go to <http://www.trpc.net> and click of the JOIN button and follow the instructions.
2. Send a check to: **TRPC at P.O. Box 7638, Tallahassee, FL 32314-7638 ATTN: NEW MEMBER** for \$53.75 with a request for the NEW MEMBERSHIP PACKET. The packet will be mailed to you.

AFTER YOU RECEIVE THE NEW MEMBERSHIP PACKET.

1. Go to <https://www2.fdle.state.fl.us/cchinet/> and complete the FLORIDA DEPARTMENT OF LAW ENFORCEMENT BACKGROUND CHECK by completing the online request and providing a credit card for the \$24.00 fee. (The fee will be deducted from your initiation)
2. Sign up for and complete one of the NRA/TRPC approved courses.

(\$50.00 of the course fee will be deducted from the initiation fee. The cost of the NRA course materials will be the responsibility of the perspective member)
3. Complete a TRPC Range & Safety Rules Test. (Provided with the New Membership Application Packet.
4. Complete the TRPC NEW MEMBERSHIP APPLICATION and
  - (a.) Attach proof of current NRA membership.
  - (b.) Attach proof of completion of NRA/TRPC approved course.
  - (c.) Attach completed TRPC Range Safety & Rules Test.
  - (d.) Attach a printout of the FDLE Background Check and submit to TRPC
5. Upon verification, you will be assigned a date and time for a NEW MEMBER ORIENTATION by a member of the TRPC Board of Directors.
6. Upon completion of the New Member Orientation and payment of the remaining initiation fee and first year membership dues (**\$248.50**) you will be issued a PROBATIONARY MEMBERSHIP CARD.
7. Following the probationary period your qualifications will be verified by the BOD and if approved you will be issued a Regular Membership Card at the next regular renewal cycle. (Subsequent yearly dues are \$100.00 + 4 hour service credit or \$180.00.)
